6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. 7. HANDLING AND STORAGE
